11) The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, **no cost of Bidding shall be reimbursable** by the Department. 12) **Refund of EMD:** The Earnest Money of all the **unsuccessful bidders** will be refunded through online process after uploading Financial Evaluation as per Government Order.

13) Prospective applicants are advised to note carefully the **minimum qualification criteria** as mentioned in **‘Instructions to Bidders’** stated in Section – ‘A’ before tendering the bids

**14) Conditional / Incomplete Quotation will not be accepted under any circumstances.**

**15) The intending Tenderers are required to quote the rate online.**

16) Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.

17) During scrutiny, if it comes to the notice of the Quotation inviting authority that the credential or

any other paper found incorrect /manufactured / fabricated, that bidder would not be allowed to participate in the financial part of the Quotation and that bid will be rejected without any prejudice.

**21) Qualification criteria:**

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement System, through logging on to <https://www.wbtenders.gov.in> (the web portal of "Uttarpara-Kotrung Municipality" Uttarpara the contractor is to click on the link for e-Tendering site as given on the web portal).

ii. **Digital Signature certificate (DSC):**

Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount. Details are available at the Web Site stated in Clause A.1. above. DSC is given as a USB e-Token.

iii. The contractor can search & download N.I.Q. & Quotation Document(s) electronically from computer once he logs on to the website mentioned in Clause A.1 using the Digital Signature Certificate. This is the only mode of collection of Quotation Documents.

iv. **Participation in more than one work:**

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job all his applications will be rejected for that job.

v. **Submission of quotation:**

Quotation are to be submitted through online to the website stated in Clause A.1. in two folders at a time for each work, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).

If any contractor is exempted from payment of EMD, copy of relevant Government Order needs to be furnished.

**No MSME is allowed for the E.M.D. exemption.**
